Applicant agrees to promptly pay all service charges. An additional service charge, computed on the same basis, will be due and payable every thirty (30) days thereafter. Waiver of anyone or more service charges by Bushwick Metals shall not be deemed to be a waiver of future service charges. Applicant further agrees that with regard to such service charges, Applicant and Bushwick Metals are parties to a written commercial contract. Should it become necessary to place this account with a collection agency or attorney for collection, Applicant agrees to pay all collection costs, attorney's fees and court costs in addition to all other sums due. Applicant warrants that all information provided is true and correct and acknowledges that the extension of credit by Bushwick Metals is based on this information being accurate and true. Applicant further agrees to keep this Credit Application updated and notify Bushwick Metals in writing of any changes, including but not limited to name changes, ownership changes, mergers or acquisitions, address and phone changes. Applicant shall submit a new or amended Credit Application when requested by Bushwick Metals.
